TOWN OF SILVER CREEK BUDGET AND LEVY WORKING MEETING FEBRUARY 6, 2024

The Budget and Levy Working Meeting of the Town Board of the Town of Silver Creek was held on Tuesday, February 6, 2024, in the Board Meeting Room at 1924 Town Road.

Present were Supervisors: Greg Hull, Chuck Voss, and Scott Krech, Town Operations and Facilities Manager Jody Reineccius, Clerk Alison Oftedahl, and Deputy Clerk Katie Anderson.

Chairman Hull called the meeting to order at 4:00 p.m. He explained the handouts that each member received including a Cash Control Report for 2023, a Taconite Production summary, a Statement of Indebtedness Report and summary sheet showing the past 7 years of levies. The Board reviewed the Budget/Levy Spreadsheet that contained budgeted and actual expenditures and receipts back to 2019, and a 10-year average in each category.

For last year, the Town spent 5% over budget but came in 9% over plan on income. The extra income was largely a result of Taconite Production taxes. The sewer spent 19% over budget but received 29% more income than expected. The income surplus came from reimbursement for the connection of new houses.

After setting preliminary numbers, Chairman Hull recessed the meeting at 5:39 pm for supper. He then reconvened the meeting at 6:13 p.m.

Supervisor Krech left prior to the end of the meeting at approximately 7:00 p.m. In working to hold down the levy, it was agreed to draw down the balance in the Fire fund. The plan assumes \$75,000 in Taconite. It also relies upon increased PILT receipts based upon information from the County Auditor. Voss and Hull agreed upon the levy included below -- an increase of 4% over the 2024 levy.
